#### **Summary Minutes**

#### **ROLL CALL**

Chair John Coleman, Directors Terry Woodrow, Richard Farrington, Donna Leatherman, Chris Wright, Brian Oneto, Jeff Davidson, and Hank Willy were present. Also present were Executive Officer Rob Alcott, Authority Counsel Gregory Gillott, Authority Secretary Lisa Stuart, and 12 visitors.

<u>PUBLIC COMMENT</u> – Katherine Evatt, Foothill Conservancy, spoke of Butte Fire-related grant opportunities that she understood Calaveras County was going to miss out on due to missing the February 1<sup>st</sup> application deadline. Director Wright later followed up with a report on Calaveras County's plans for filing the grant applications and explained there were different deadlines for competitive and non-competitive applications.

Richard Sykes spoke of the San Joaquin County Groundwater Banking project. Working with North San Joaquin Water Conservation District, the project plans to move 1,000 acre-feet of water from the Mokelumne aqueduct into the northeastern San Joaquin groundwater basin and later remove up to 500 acre-feet to demonstrate the project's feasibility.

#### **AUTHORITY BUSINESS**

1. Minutes of October 2, 2015 Regular Meeting Minutes

**Motion 01-16** to approve the minutes of the regular October 2, 2015 Governing Board meeting was made by Director Woodrow, seconded by Director Willy, and carried by voice vote: Yea 6 – Nay – 0 Abstain – 2 (Directors Oneto and Davidson).

#### 2. USFS Partnership and Sierra Nevada Conservancy Watershed Improvement Grant

Following the July 24 Board workshop on potential forest partnership opportunities with the U.S. Forest Service (USFS) and the Bureau of Land Management (BLM), and the status update presented at the October 2 UMRWA Board meeting, staff have been working with federal officials to develop a draft USFS Master Stewardship Agreement (MSA) and a framework program plan for presentation and discussion at this meeting. Concurrently, staff has identified a potential Sierra Nevada Conservancy grant opportunity that would facilitate the completion of an array of USFS forestry projects that are included in the USFS's Cornerstone Project. These two pending UMRWA initiatives were discussed and Teresa McClung, USFS, gave a presentation on the Hemlock Project.

Discussion of the MSA centered on procurement policies, including the ability for local contracting; calling out fire hazard mitigation specifically in the agreement and prioritizing fuel reduction work verses meadow restoration work; and including a water supply enhancement component (snow retention).

#### **Motion 02-16** to

- (1) Authorize staff to:
  - a. Develop a final UMRWA USFS Master Stewardship Agreement for review and approval at the April 22 Board meeting.

- b. Draft a Supplemental Project Agreement for the Pumpkin Hollow Restoration Project for review at the April 22 Board meeting.
- c. Prepare a draft Pumpkin Hollow Organization and Work Plan for review with the Board on April 22.
- d. In collaboration with Authority Counsel draft CEQA documentation and a schedule for fulfilling the associated public review and approval process for review by the Board on April 22.
- (2) Authorize staff to complete the SNC grant application in collaboration with the USFS and submit the application by the March 1 deadline.
- (3) Approve Resolution No. 2016 1 authorizing the Executive Officer to submit a grant application for funding under the Sierra Nevada Conservancy's Prop 1 Watershed Improvement Program

was made by Director Davidson, seconded by Director Farrington, and carried by voice vote: Yea 8 – Nay – 0 Abstain – 0.

#### 3. Status Updates on Implementation Grants

This agenda item presents a summary of the Department of Water Resources (DWR) evaluation of the 2015 Round 3 UMRWA Implementation Grant proposal and brief updates on three previous UMRWA Proposition 84 Implementation Grants awarded by the DWR. The three previously awarded grants are the 2014 Drought Grant (April 2015), the Round 2 Implementation Grant (September 2014) and the Round 1 Implementation Grant (April 2012). The EO provided status updates on the projects currently in progress.

Following Board discussion that there was consensus that staff would follow up with DWR to learn the basis for DWR's Round 3 scoring evaluation.

#### 4. Expansion of Vintage Home Retrofit Program

The Vintage Home Replacement Program (VHR), the toilet and showerhead replacement effort for the Camanche area funded by the Round 2 Implementation Grant, was scheduled to conclude October 31. As of that date the program had resulted in the installation of 117 high efficiency toilets (21.0% of the 558 target) and 105 low water use showerheads (18.8% of the 558 target).

Because few, if any, additional applications will be submitted from the existing Camanche target area the DWR Project Manager and AWA General Manager have been consulted to determine if the program target area could be expanded to other communities served by the Mokelumne River water supply through AWA. Based on DWR's initial guidance that fixture replacements can be allowed, but only in DAC communities served by AWA, it is anticipated that UMRWA will take the steps necessary to create an expanded program target area.

Efforts to determine what types of DWR approval are needed to implement an expanded program have not yet resulted in a definitive answer. An amendment to the UMRWA – EcoTech Services agreement (which engages EcoTech to administer the program for UMRWA) may also be necessary.

**Motion 03-16** to approve and authorize the Executive Office to sign, upon Authority Counsel's concurrence, any required amendment to the DWR Round 2 Implementation Grant Agreement and/or amendment to the UMRWA – EcoTech Services agreement to facilitate a DWR and Amador Water Agency authorized expansion of the Vintage Home

Retrofit Program was made by Director Davidson, seconded by Director Farrington, and carried by voice vote: Yea 8 – Nay – 0 Abstain – 0.

#### 5. CSRC&D Agreement for FY 2016 Watershed School Program

UMRWA has provided funds to support the local public schools' Youth Watershed Stewardship Program (YWSP) since Fiscal Year 2006. Through a series of contracts with the Central Sierra Resource Conservation and Development District (CSRC&D), the sponsor of the YWSP, Authority members have provided about \$186,000 in total funding to support the program's creation and continuation.

The approved FY2016 UMRWA budget includes \$16,500 to continue the Authority's support of the local school Youth Watershed Stewardship Program.

This program is facilitated through an agreement with the Central Sierra Resource Conservation and Development, Inc. and carried out by Stewardship through Education, LLC (STE), a local teacher's organization. This will be the ninth year UMRWA has supported this school-based stewardship program. The agreement between UMRWA and CSRC&D for the 2016 program was provided in the board packet.

Discussion ended with a request to have STE (Mary Anne Garamendi or representative) give a presentation at next UMRWA meeting.

**Motion 04-16** to approve the agreement with the CSRC&D for Fiscal Year 2016 and authorize the Executive Officer to execute the agreement, was made by Director Oneto, seconded by Director Leatherman, and carried by voice vote: Yea 8 – Nay – 0 Abstain – 0.

#### 6. Agreement with RMC to Develop Data Management Program

The approved FY 2016 UMRWA budget includes funding to create a Data Management Plan and Program. A draft Consulting Services agreement with RMC Water and Environment accompanies this agenda item and includes a template scope of work and budget. A final version of the agreement was distributed at the Board meeting.

Creation of the Data Management Plan and Program will fulfill an UMRWA obligation resulting from entering into Integrated Regional Water Management (IRWM) Implementation Grants agreements with DWR. Each of the project sponsors (to date AWA, CCWD, Calaveras County, EBMUD) that received state funding under prior (and potentially future) grant awards is required to collect and report project performance data for a ten year period. As the grantee, UMRWA is responsible for fulfilling this task. As RMC has first-hand knowledge of these projects (due to RMC's preparation of the successful grant applications) it is well positioned and experienced to perform this task.

Directors requested that the EO ensure the contract with RMC specifically states that the data is the property of UMRWA and will be released to UMRWA upon request.

**Motion 05 -16** to approve a consulting services agreement with RMC Water and Environment to develop the UMRWA Data Management Plan and Program as described in Exhibit A to the agreement in an amount not to exceed \$27,390 and authorize the Executive Officer to sign the agreement was made by Director Davidson, seconded by Director Wright, and carried by voice vote: Yea 8 - Nay - 0 Abstain - 0.

#### 7. Butte Fire Update and Forest Health Initiatives

Richard Sykes provided a brief update regarding EBMUD's water quality monitoring in the Mokelumne River watershed following the Butte Fire.

Also, as discussed by the Board at its October 2, 2015 meeting, UMRWA has received \$5,000 from EBMUD as a contribution to local fire recovery efforts.

The Board discussed a process recently initiated by EBMUD to investigate local, state and federal efforts to promote healthy forest and watershed initiatives, including any pending legislative actions. These forest and watershed initiatives promote proactive forest management, which can include forest thinning and other fuel treatments, meadow restoration, road removals or reconstruction and other actions, as a way to reduce the risk of high-severity wildfires and improve ecosystem function. Such an approach may provide an array of benefits to a wide range of stakeholders. The Board briefly discussed UMRWA's potential role in supporting legislation or rulemaking that promote forest health.

Director Farrington thought EBMUD's board may be interested in learning of projects that EBMUD's own staff is doing around Pardee in order to help educate the members on practices that benefit fire prevention/water quality.

Kim Carr spoke to the board previously regarding a study to assess investments in forest health to determine who should fund projects and the level of funding for benefit received. A request was made for an update on the avoided cost study at the April 22 meeting.

#### 8. Basic Financial Statement for the Year Ending September 30, 2015

East Bay MUD, whose Finance Director serves as the Authority's Treasurer, maintains the Authority's financial records. The Authority's financial records for the year ending September 30, 2015 have been audited by the independent accounting firm Maze and Associates. This year's audit is presented in the document titled *Upper Mokelumne River Watershed Authority Basic Financial Statements for the Years Ending September 30, 2015 and September 30, 2014.* 

In addition to the Basic Financial Statements, Maze and Associates has prepared a companion document titled *Memorandum on Internal Controls and Required Communications*.

These documents present a general overview of the Authority's finances, demonstrates the Authority's accountability of the monies it manages, and provides general information related to the preparation of the audit for the Authority's Governing Board and management. The audit reports neither find nor describe any financial problems or irregularities. These reports were provided to the board electronically in the agenda packet and hard copies were distributed to all interested parties at the meeting.

**Motion 06-16** to accept the Financial Statements for filing was made by Director Davidson, seconded by Director Woodrow, and carried by voice vote: Yea 8 – Nay – 0 Abstain – 0.

#### 9. Treasurer's Report – First Quarter FY 2016

The Treasurer's Report for the First Quarter of Fiscal Year 2016, ending December 31, 2015, was presented to the Board.

**Motion 07-16** to accept the Treasurer's Report for filing was made by Director Leatherman, seconded by Director Willy, and carried by voice vote: Yea 8 – Nay – 0 Abstain – 0.

Board Member Comments: CCWD Director Terry Strange spoke from the audience about a presentation made to CCWD's board by Columbia College's Watershed Technology Program and Steve Christianson regarding the start of their Water Institute; they have an interest in presenting to UMRWA, as well. Director Farrington stated his pleasure that UMRWA is working with the USFS and would recommend that this information be brought back to the member agencies via their representatives. He also shared that Bill Hague, BLM, presented at the ACCG and shared that BLM was awarded \$2.25 million for aerial application of mulch in the Butte Fire area. He also commended the work of EBMUD's Chris Swann and crew on the Ponderosa Way area of the Butte Fire. He stated that he has seen a presentation Chris gave at the Mokelumne River Association meeting the previous week and went to see the work first hand. Other board members agreed and stated that they too had seen the work and felt the EBMUD crew was instrumental in improving that area after the fire. Director Coleman spoke regarding the coming State Water Resources Control Board meeting and encouraged members to get involved since water rationing may still be required even for agencies whose water supplies are filled because some state and federal reservoirs and water suppliers are still really low; final decisions will be made in May.

On January 23, 2015 Nic Enstice from the Sierra Nevada Conservancy (SNC) provided a presentation on the Mokelumne Avoided Cost Analyses Study. At the last UMRWA Board meeting a request was made to invite a SNC representative to provide an update on the status of activities following last year's completion of that study. Mr. Michael Pickard, SNC's Area Representative, has been invited to make the requested presentation and provide information on other potential SNC activities that may be of interest to UMRWA and its members.

#### Title:

Pumpkin Hollow Restoration Project Negative Declaration and Project Approval (Public Hearing)

#### Recommended Actions:

- (1) Approve the Initial Study and adopt the Negative Declaration for the Pumpkin Hollow Restoration Project.
- (2) Authorize the filing of a Notice of Determination with Calaveras County.
- (3) Approve and authorize implementation of the Pumpkin Hollow Restoration Project conditioned upon SNC's award to UMRWA of the \$500,000 Healthy Watersheds grant and a Supplemental Project Agreement with the USFS.

#### Summary:

An Initial Study (IS) was prepared to address the Pumpkin Hollow Restoration Project's environmental impacts. As documented in the IS it was determined the project could not have a significant impact on the environment and a Negative Declaration was prepared. A copy of the Initial Study and proposed Negative Declaration are provided separately.

UMRWA's CEQA review and documentation follows and is consistent with the USFS's environmental review of the project under NEPA. The USFS's Hemlock Landscape Restoration Environmental Assessment was prepared in 2015 and Decision Notice/Finding of No Significant Impact issued in January 2016.

#### Discussion:

The Pumpkin Hollow Restoration Project (Project) will improve ecological resilience of forested communities within the Stanislaus National Forest project boundaries through forest, meadow and aspen restoration and fuels management treatments. These treatments are designed to increase resistance to catastrophic wildfire while improving water supply through snowpack accumulation and persistence. This project will result in a forested landscape expected to better withstand catastrophic wildfire and the ecological and water quality damage potentially caused by such events.

The Project is located on the Calaveras Ranger District of the Stanislaus National Forest in Calaveras County, California. The majority of project activities are planned in the upper headwaters of Blue Creek that flows into the Mokelumne River with a small area near Big Meadow Creek that flows into the North Fork Stanislaus River. Large-scale catastrophic wildfires have occurred in this region of the Sierra Nevada range for decades.

The Project is a subset of the 14,075-acre Hemlock Landscape Restoration project (Hemlock) that is in turn a component of the even larger Cornerstone Collaborative Forest Landscape Restoration Program (390,904 acres). Elevations within the 972-acre Pumpkin Hollow Project area range between 6,100 feet and 7,300 feet.

#### **Environmental Review Process/Public Outreach**

A combined Notice of Intent to Adopt a Negative Declaration, Notice of Public Hearing, and Notice of Public Review of a Proposed Negative Declaration (Notice) was published on March 22, 2016, with a 20-day public comment period that ended on April 11, 2016. The Notice was posted on the Authority's website and was made available in hard copy at the Authority's office at 15083 Camanche Parkway South, Valley Springs, CA. Copies of the document were also sent on March 18 to individuals who regularly receive UMRWA agenda packets, as well as to the affected District Rangers at the Stanislaus and El Dorado National Forest district offices.

#### **Public Comments**

No comments were received during the review period.

#### Schedule

Project planning is expected to continue through 2016. Bid packages are expected to be ready for release to qualified bidders in early 2017. Work activities are expected to begin when weather and field conditions are suitable in spring 2017 and be completed by fall 2018.

#### Title:

USFS Master Stewardship Agreement and Related Topics

#### Recommended Action:

Approve the Master Stewardship Agreement and authorize the Executive Officer to sign.

#### Summary:

The Board on January 22 authorized staff to work with the USFS to finalize the Master Stewardship Agreement, explore the Supplemental Project Agreement for the Pumpkin Hollow Restoration Project, and begin developing a Pumpkin Hollow organization and work plan. Additionally, staff identified a potential source of grant funding to enhance UMRWA's staff capacity. These topics are presented or discussed in this agenda item.

#### Master Stewardship Agreement

The Master Stewardship Agreement (MSA) has been finalized and is presented today for Board approval (the document is provided separately). Under the MSA, UMRWA will be the lead agency for implementing agreed-upon phased portions of the Cornerstone Project. This means UMRWA will be lead for CEQA (note previous agenda item), contracting for the work to be done, overseeing that work (with the USFS having a significant role), securing matching funds and handling all the associated accounting and treasury functions.

The MSA lays out the Authority's and the USFS's mutual interests (e.g. fire risk reduction, water quality, reforestation, water supply protection) and the parameters for working to implement the Cornerstone Project. However, no actual Cornerstone work can be initiated until the two partners enter into Supplemental Project Agreements (SPA) for any phased element. The SPA lays out each partner's project-specific obligations and related details for implementing a project (which in the context of the 390,000-acre Cornerstone Project would constitute an element of Cornerstone).

#### Sierra Nevada Conservancy Grant Application – Pumpkin Hollow Restoration Project

The first potential SPA is for the Cornerstone element called the Pumpkin Hollow Restoration project that was considered in previous agenda item. UMRWA submitted a grant application to Sierra Nevada Conservancy (SNC) under its Prop 1 Watershed Improvement Program on March 1. The SNC grant application was prepared by UMRWA associate Karen Quidachay in collaboration with USFS staff. The application requests \$500,000 of Prop 1 monies to partially fund the Pumpkin Hollow Restoration Project. If awarded, the USFS will match with \$327,499 for a total project budget of \$827,499.

<u>Supplemental Project Agreement – Pumpkin Hollow Restoration Project</u>

Work to develop the draft SPA for the Pumpkin Hollow Restoration Project has just begun. The draft agreement will be presented for Board review at the July meeting. Staff has registered UMRWA on the federal SAM system that is a pre-requisite for receiving federal project funding

An UMRWA organization and work plan is being discussed with member agencies and Authority Counsel with the expectation that basic elements will be presented to the Board for preliminary discussion and feedback in July.

Table 1 below displays the conceptual timeline for accomplishing the various tasks required for UMRWA to complete the Pumpkin Hollow Restoration Project as will be provided under the MSA.

#### Healthy Watersheds Consortium Grant Application

On March 14 UMRWA submitted a grant application seeking \$230,000 over 4 years, to be matched with \$80,000, to hire a Forestry Program Coordinator (FPC) to organize/lead a program for the protection and enhancement of Upper Mokelumne River forests, establish formal partnerships with the USFS and BLM, develop funding to protect forested lands from wildfires, preserve freshwater ecosystems, and work with federal partners to establish/execute forest management projects to protect/improve management of the ~390,000 acres of Cornerstone watershed lands. Awards are expected to be announced by the end of April.

Also presented are brief updates on three previous UMRWA Proposition 84 Implementation Grants awarded by DWR. These three previously awarded grants are the 2014 Drought Grant (April 2015), the Round 2 Implementation Grant (September 2014) and the Round 1 Implementation Grant (April 2012).

DWR evaluation of Round 3 Implementation Grant application:

DWR released its draft recommended awards for the final Round 3 Prop 84 Implementation Grants in late October. The top scoring 6 (of 9) applications are shown in the table below.

Per the Board's request the EO met with DWR staff via conference call to discuss DWR's scoring rationale. In summary, DWR said the top six applications in our funding area were 'extremely competitive' and in order to differentiate one application from another it was necessary for DWR to scrutinize and distinguish the applications based on very minor and technical considerations. In addition to re-reviewing UMRWA's score DWR also reviewed its scoring of three other applications. In all four instances DWR revised upward the final scores (see table above). These adjustments, however, affected neither the final award amounts nor the agencies that will receive those awards.

#### 2014 Drought Grant:

The Drought Grant agreement with DWR was approved by the UMRWA Board on January 23, 2015 and executed by DWR on April 23rd. The associated Project Sponsors agreement between AWA and UMRWA has also been finalized. The two Amador Water Agency projects to receive funding under this agreement, Ione Water Treatment Plant Backwash and Amador Raw Water Pipeline, are under development. There are no known or anticipated issues with these projects.

Phase 2 Expansion of the Vintage Home Replacement Program

#### Recommended Action:

For discussion/possible action

#### Summary:

The Vintage Home Replacement Program (VHR) is the toilet and showerhead replacement effort that initially targeted the DAC communities in the Camanche area as funded by UMRWA's Prop 84 Round 2 Implementation Grant. As of December 31st (the date ending the 'Phase 1' program) the program had resulted in the installation of 134 high efficiency toilets (24% of target) and 119 low water use showerheads (21% of target). Responding favorably to UMRWA's request, DWR has authorized a 'Phase 2' VHR program that will target other DAC communities that use Mokelumne River water supply in Amador County. An amendment to the EcoTech Services agreement (EcoTech is the firm that administers the program for UMRWA) provides for the Phase 2 effort was approved by the Board on January 22, 2016.

The expanded Phase 2 program will target the following cites and communities within Amador County:

- Amador City (Water Retailer: Amador Water Agency)
- Sutter Creek (Water Retailer: Amador Water Agency)
- City of Jackson (Water Retailer: City of Jackson, Wholesaler: Amador Water Agency)
- City of Plymouth (Water Retailer: City of Plymouth, Wholesaler: Amador Water Agency)
- Drytown (Water Retailer: Drytown County Water District)
- Buena Vista (Water Retailer: Jackson Valley Irrigation District)

EcoTech has coordinated with potential program participants and has drafted a Phase 2 Program Development Report. The details of the finalized Phase 2 program will be shared with the Board at the July meeting.

Resolution Concerning AB 142 Cost Sharing Agreement

#### Recommended Action:

Approve Resolution No. 2016 - 2 regarding the AB 142 cost-sharing agreement with the California Natural Resources Agency.

#### Summary:

AB 142 requires the Secretary of the California Natural Resources Agency to submit a report to the Legislature and Governor no later than December 3l, 2017 to include a recommendation on the suitability or non-suitability for addition to the Wild and Scenic system of each of the designated segments of the Mokelumne River. The bill also requires the Secretary to enter into a cost-sharing agreement with the Upper Mokelumne River Watershed Authority that specifies the state and UMRWA each pay a portion of the cost of the report.

The cost-sharing provision in the bill provides that the state pay not more than 50 percent of the cost of the study and report, with the remaining cost to be paid by UMRWA. The UMRWA payment may consist of appropriated funds or a contribution of services.

At its April 24, 2015 meeting, the UMRWA Board unanimously approved Motion 09-15, which states: *Approve a conditional commitment of up to \$100,000 to support the study required by AB142 based on individual agency approval with the goal of having the state fund the entire amount.* UMRWA Members that subsequently pledged their pro-rated financial contribution to the study were AWA, CCWD, CPUD, JVID and EBMUD. The sum of those pledges totals approximately \$100,000.

# UPPER MOKELUMNE RIVER WATERSHED AUTHORITY RESOLUTION 2016 - 2

#### AUTHORIZING A COST-SHARING AGREEMENT WITH THE CALIFORNIA NATURAL RESOURCES AGENCY AND AUTHORIZING THE EXECUTIVE OFFICER TO EXECUTE AND ADMINISTER THE AGREEMENT

WHEREAS, Governor Brown signed Assembly Bill 142 on October 9, 2015, which designates a process to study and report to the Governor and Legislature the suitability or non-suitability of designated sections of the Mokelumne River for addition to the system provided for by the State Wild and Scenic Rivers Act; and

WHEREAS, water resources originating from the Mokelumne River watershed have been and will remain a significant source of the water for people, the environment, and agribusiness and provide an invaluable contribution to the economy and public well-being; and

WHEREAS, the Upper Mokelumne River Watershed Authority (UMRWA) is a regional water management group as defined by the California Water Code. A Joint Powers Agency formed in 2000 to address water quality, water supply and environmental matters, UMRWA is comprised by Amador Water Agency, Calaveras County Water District, Calaveras Public Utility District, East Bay Municipal Utility District, Jackson Valley Irrigation District, Alpine County Water Agency and the counties of Amador, Calaveras and Alpine; and

WHEREAS, the Secretary of the California Natural Resources Agency (CNRA) is required by AB142 to enter into a cost-sharing agreement with the Upper Mokelumne River Watershed Authority where the state shall not pay more than 50 percent of the cost of the study and report on the suitability or non-suitability of designated sections of the Mokelumne River for addition to State Wild and Scenic Rivers Act system, with the remaining costs to be paid for by the authority; and

WHEREAS, UMWRA and CNRA have determined that the cost for the study and report required by AB 142 will not exceed \$250,000; and

WHEREAS, the report required for the segments of the Mokelumne River designated for potential addition to the State Wild and Scenic Rivers Act system shall be submitted to the Legislature and Governor no later than December 31, 2017, and shall include a clear recommendation on the suitability or non- suitability for addition to the system of each of the designated segments of the Mokelumne River; and

WHEREAS, the study and report shall provide for public input from a broad range of stakeholders; and

WHEREAS, the cost-sharing agreement between UMWRA and CNRA shall not preclude any private donations or contributions from interested parties to be used for the purposes of this subdivision according to provisions in AB 142; and

NOW, THEREFORE, BE IT RESOLVED, that UMWRA and CNRA will, contingent upon appropriation, enter into a cost-sharing agreement where each party is responsible for 50 percent of the costs of the required

study and report, not to exceed \$250,000 with UMRWA's payment consisting of appropriated funds or a contribution of services; and

BE IT FURTHER RESOLVED, the Executive Officer is authorized to enter into and sign the cost-sharing agreement and any amendments thereto with the State of California for the purposes of the study and report required by Assembly Bill 142 consistent with this the principals in this Resolution.

Draft Proposed Fiscal Year 2017 UMRWA Budget

#### Recommended Action:

Endorse the draft FY 2017 UMRWA budget and authorize the EO to transmit the draft budget to Member Agencies for review and comment.

#### Summary:

In July 2011 the Board adopted an UMRWA Budget Policy and Procedure. The procedure sets out a budget development process and schedule as shown below.

A draft FY 2017 budget is presented in Table 1 (next page). Presented in Table 2 is a general estimate of the Member Agency funding allocations, including estimates of in-kind services provided this fiscal year. Estimates of the resulting Member Agency funding allocations and the associated assessment amounts are shown in Table 3.

The draft budget is organized to distinguish between the Authority's two primary revenue sources, Member Agency funding and grant funding. Accordingly, the Authority's work activities planned for FY 2017 are similarly organized. Below are the proposed/planned work tasks for FY 2017.

**For the Member-funded portion** of the draft FY2017 budget the following activities are assumed:

- 1) Add \$8,000 to the Authority Board and Authority administration budget (for data plan and website technical support) for a total \$68,000 (up from \$60,000).
- 2) Maintain the annual funding support for the local school watershed education program at \$16,500.
- 3) Provide \$125,000 in new funding to pay the UMRWA half-share of the AB142 Wild and Scenic study.

4) Maintain the \$100,000 to pay costs for developing grant applications that allow UMRWA to apply for potential Prop 1 and other grant opportunities.

**For the grant funded portions of the budget**, the funding associated with activities related to Prop 84 Planning and Implementation grants for FY 2017 will be determined in September, the final month of UMRWA's fiscal year. Awarded but uncollected grant funds, along with unspent FY 2016 grant dollars will be carried forward to FY 2017. Those amounts will be determined based on the end of fiscal year Treasurer's Report as of September 30, 2015. As is the case each fiscal year no Member Agency funding is budgeted to support grant-funded activities in FY 2017.
